Guidelines for Applicants:

The completed Scholarship Application and Essay must be postmarked by **March 15, 2019**.

Recipient will be chosen by an impartial committee selected by the Scholarship Committee Chair and approved by the PSCA Executive Director.

The School Counselor about whom you are writing must be a certified School Counselor and be currently employed as a School Counselor in Pennsylvania.

Final selection will be made by May 6, 2019. Announcement of the recipient will be made at the recipient's high school. Payment of the scholarship will be made directly to the post-secondary institution upon written verification of the student's enrollment.

The format of the application form may not be changed in any way.
All materials submitted become the property of PSCA.
